Rodent menace hits Puri's historic

BHUBANESWAR:

The authorities running the Jagannath Temple of Puri may need a Piped Piper to rid it of rodents that have infested the 12th-century shrine. The rodents, whose numbers increased manifold during the absence of devotees in the wake of the COVID-19 pandemic, have been nibbling away at the attires of the gods - Jagannath, Balabhadra and Subhadra - in the shrine. The servitors and priests have voiced fears that the rodents may damage the wooden idols of the deities, though temple administrator JitendraSahoo feels there is no need to take fright. "There were few rodents in the sanctum sanctorum of the temple but their number increased significantly after the COVID-19 pandemic," Ramachandra Dasmohapatra, a servitor, said. The rodents also create a disturbance when the priests perform rituals, said Satyanarayan Puspalak, representing the group of servitors who decorate the deities with garlands. "The rats devour the flowers offered to the deities and nibble away at the valuable attires of the gods," Puspalak said. Though the rodents cause a nuisance in the 'GarvaGruha' (sanctum sanctorum), the servitors are not permitted to kill animals or poison them inside the temple, said Bhaskar Mishra, a researcher in the Jagannath culture. "The temple records of rights (ROR) mention how to deal with rodents, bats, and monkeys found on the temple premises. One cannot take away the life of any living creature as stipulated by the temple rules," Mishra said. Though the population of rodents increased due to the absence of devotees inside the temple during the lockdown in 2020 and 2021, the rodents are not new to the place, Mishra said. Some animals live on the Jagannath Temple premises for generations as they get an adequate quantity of the leftover 'Mahaprasad', he said. "The temple ROR clearly states that some specific servitors are given the responsibility to catch the rodents alive and release them outside," Mishra said. Temple administrator JitendraSahoo said that the Shree Jagannath Temple Administration (SJTA) was aware of the rodent menace. "We are laying traps to catch the rats alive and are releasing them outside according to the provisions adopted over the years. We are not allowed to use rat poison in the temple," Sahoo said. Noting that there was no danger to the wooden deities, Sahoo said they are being regularly polished with sandalwood and camphor. The Wildlife Division of Puri said monkeys, bats, pigeons and even snakes can be found on the premises of the Jagannath temple.

MukarramJah passes away, KCR orders state funeral

HYDERABAD:

Chief Minister K. Chandrashekar Rao on Sunday expressed condolences on the demise of MukarramJah, grandson of the last Nizam of Hyderabad Mir Usman Ali Khan. MukarramJah, who is the titular Nizam of Hyderabad, passed away in Istanbul on Saturday. "We are deeply saddened to inform that Nawab Mir Barkat Ali Khan Walashan Mukarram Jah Bahadur, H.E.H The Eighth Nizam of Hyderabad passed away peacefully in Istanbul, Turkey late last night at 10:30 pm (IST)," the statement said. "As per his desire of being laid to rest in his home land, his children are scheduled to travel to Hyderabad with the mortal remains of the late Nizam on Tuesday, 17th January 2023." According to his office, the body will be taken to the Chowmahalla Palace and after completing the required rituals the burial will take place at the AsafJahi family tombs. In recognition of MukarramJah's social services in the fields of education and medicine for the poor as the successor of the Nizam, ChandrashekarRao directed Chief Secretary SanthiKumari to conduct Jah's last rites with the highest state honours.

PM Modi holds roadshow as BJP national executive begins in Delhi

NEW DELHI:

Enthusiastic BJP workers and supporters lined the roads to greet Prime Minister Narendra Modi during his roadshow here as the party's two-day national executive began in Delhi on Monday. In an atmosphere enlivened by music and the cheering crowd, the roadshow started from Patel Chowk and continued till the NDMC convention centre. People showered Modi with flower petals and chanted slogans in his support. Huge cutouts of the prime minister were placed along the road, besides several posters highlighting various initiatives of the government and also India's presidency of the G20. Stages had been erected at places. Folk artistes from several states performed on some of them, while others blared patriotic songs. BJP president J P Nadda welcomed



Modi at the venue of the party's meeting, which started upon the prime minister's arrival. While Modi has been holding roadshows frequently, it is not very often that he does it ahead of the party's executive meet, which has been organised several times in the national capital now. BJP leaders noted that Modi had held a roadshow ahead of the party's national executive in Odisha, and added that the exercise proved to be helpful in galvanising cadre and supporters. With Lok Sabha polls due in the first half of next year, the enthusiastic roadshow will also help energise the party's Delhi unit after its loss to the Aam Aadmi Party in the recent municipal polls, they said.

To infuse transparency, Centre to CJJ for having its representatives on SC collegium

NEW DELHI:

Union Law Minister Kiren Rijiju has written to Chief Justice of India (CJI) D.Y. Chandrachud suggesting to include the government representatives on the collegium, which decides on judges' appointment. The Law Minister, in a letter, said having government representatives will infuse transparency and public accountability. The letter has come against the backdrop of the ongoing row between the Centre and judiciary over the appointment of judges. The Law Minister's letter is the latest in the series of criticism of the collegium system by constitutional authorities, which included the Vice President and the Lok Sabha Speaker. Delhi Chief Minister Arvind Kejriwal, in a tweet, said "This is extremely dangerous. There should be absolutely no

government interference in judicial appointments. Responding to Delhi CM's tweet, Rijiju tweeted: "I hope you honour court's direction! This is precise follow-up action of the direction of Supreme Court Constitution Bench while striking down the National Judicial Appointment Commission (NJAC) Act. The SC Constitution Bench had directed to restructure the MoP of the collegium system." In another tweet, the Law Minister said, "The contents in the letter to hon'ble CJI are exactly in conformity with the observations and directions of the Supreme Court Constitution Bench. Convenient politics is not advisable, especially in the name of Judiciary. Constitution of India is supreme and nobody is above it." Last year Rijiju, at a



media event, had said that judges only recommend the appointment or elevation of those they know and not always the fittest person for the job. Later the Law Minister, in December last year, had said that there is no such proposal to reintroduce the National Judicial Appointments Commission (NJAC) with suitable modifications. He said it while responding to the several questions raised by politicians, Mallikarjun Kharge and Dr John Bittas in Parliament. Rijiju said the appointment of the judges of the constitutional courts is a continuous, integrated and collaborative process between the executive and

the judiciary. On November 28, last year, the Supreme Court took strong exception to Law Minister Kiren Rijiju's recent comment on the collegium system of appointing judges, saying it should not have happened. The top court had also slammed the Central government for delay in the appointment of judges and said that the government can convey its objections to the recommendations made by collegium, but it cannot sit on the names without conveying any reservations. The National Democratic Alliance government, in 2014, brought the NJAC Act in an attempt to change the system of appointment of judges. The Supreme Court reiterated the collegium system and struck down the NJAC Act along with the 99th Constitutional Amendment Act in a 4:1 ratio.

KTR seeks NRIs support for government programmes

HYDERABAD:

Industries and IT minister K.T. Rama Rao has asked non-resident Indians living in Europe to participate in the state government's programmes like Mana Ooru-Mana Badi and work as goodwill ambassadors to promote Telangana as well as India. Urging them to be part of the state's growth story, the minister assured of complete support even if anyone wants to make small investments in the state and create jobs. The minister is in Davos, Switzerland, to take part in World Economic Forum. He was speaking at the 'Meet and Greet' programme organised by the Indian diaspora in Zurich on Sunday. The event was attended by Indians living in Switzerland, United Kingdom, Denmark, Germany, Norway, and other countries. During the meet, the minister spoke about the progress achieved by Telangana government since the inception of the state in 2014 and the holistic



development model being adopted by the state government. Rama Rao said that paddy production in Telangana was at 68 lakh tonnes and procurement by the government was 24 lakh tonnes at the time of the formation of the state in 2014. By 2022, the production and procurement grew to 3.5 crore tonnes and over two crore tonnes respectively. IT exports from Telangana grew from Rs 57,000 crore to Rs 1.83 lakh crores, per capita of Telangana grew from Rs 1.24 lakh to Rs 2.78 lakh, while national average was Rs 1.49 lakh, during the same period, he said. Speaking about the progress achieved in the villages, under the leadership of Chief

Minister K Chandrashekar Rao, he said that now every village has a nursery, vaikuntadhamam (crematorium), and 10 per cent of Gram Panchayat budget is earmarked as green budget, and the government has provided a tractor and a tanker for every gram panchayat in the state. He said that the needs of farmers were taken care of by providing free power round-the-clock, Rythu Bandhu, Rythu Bima, high-quality seeds, fertilisers and pesticides, and RythuVedikas were built. He said that Palle Pragathi was a role model, and that the needs of people in villages were thoroughly thought through by CM Rao, which no other CM or PM did. The industries minister said that five revolutions were unfolding in Telangana at present, which are pink revolution (meat), yellow revolution (oil palm), blue revolution (inland fisheries), white revolution (milk) and green revolution (crops).

Sonia initially struggled to learn Indian traditions, disliked politics: Priyanka

BENGALURU:

Italy-born Sonia Gandhi initially struggled to learn Indian traditions and disliked politics, her daughter and Congress general secretary Priyanka Gandhi Vadra said on Monday. Addressing a women-centric convention organised here by the Karnataka Pradesh Congress Committee in the poll-bound State, the Congress leader said she was brought up by two brave and strong women - her grandmother Indira Gandhi and mother Sonia Gandhi. She recalled that she was eight-years-old when Indira Gandhi lost her 33-year-old son. But the very next day of Sanjay Gandhi's death, she went



to work to serve the nation and that was the sense of duty and her "inner shakti". Indira Gandhi continued to serve the nation until she died. Priyanka Gandhi said Sonia Gandhi fell in love with Rajiv Gandhi at the age of 21. "She (Sonia) came all the way from Italy to India to get married to him. She struggled to learn our traditions. She learnt the ways of India. She

imbibed everything from Indira and at the age of 44, she lost her husband. Even though she disliked politics, she took the path to serving the nation and she served it all her life till today when she is 76 years old," Priyanka Gandhi said. Priyanka said she had learnt a "very important thing" from Indira Gandhi, Sonia Gandhi and hundreds of ordinary women who struggle everyday in life. "No matter what happens to you in your life, no matter how big a tragedy you face, how deep your struggles are... Whether at home or work or outside, you have the capacity to stand up and fight for yourself," Priyanka said.

Govt "intimidating" judiciary with view to "capture" it: Congress on Rijiju's letter to CJI

NEW DELHI:

The Congress on Monday accused the government of "intimidating" the judiciary in a bid to "capture" it, after Law Minister Kiren Rijiju wrote to Chief Justice of India D Y Chandrachud suggesting the inclusion of the Union and state government representatives in the Supreme Court and high court collegiums. Rijiju has sought this representation, saying it will help infuse transparency and public accountability in the selection of judges. "The VP's assaults. The Law Minister's attacks. All this is

orchestrated confrontation with the judiciary to intimidate and thereafter capture it totally," AICC general secretary Jairam Ramesh said on Twitter. "The Collegium needs reform. But what this Government wants is complete subservience - Its remedy is a poison pill for the judiciary," he also said. Justifying the letter to CJI, Law Minister Rijiju said in a tweet, "the contents in the letter to hon'ble CJI are exactly in conformity with the observations and directions of the Supreme Court Constitution Bench." "Convenient politics is not advisable, especially in the name of the



Judiciary. The Constitution of India is supreme and nobody is above it," Rijiju also said. He said the government's demand for the inclusion of its representatives and that of states in collegiums of the Supreme Court and high courts was the "precise follow-up action"

suggested by the apex court while striking down the National Judicial Appointment Commission Act. Rijiju made the remarks while responding to Delhi Chief Minister Arvind Kejriwal, who dubbed as "extremely dangerous" the government's move to ask the Supreme Court to include its nominees in the collegium. "I hope you honour Court's direction! This is a precise follow-up action of the direction of the Supreme Court Constitution Bench while striking down the National Judicial Appointment Commission Act. The SC Constitution Bench had directed

to restructure the MoP (Memorandum of Procedure) of the collegium system," Rijiju said on Twitter. "This is extremely dangerous. There should be absolutely no government interference in judicial appointments," Kejriwal said on Twitter. In November, Rijiju had said that the collegium system of making judicial appointments was "alien" to the Constitution. Vice President and Rajya Sabha Chairman Jagdeep Dhankhar and Lok Sabha Speaker Om Birla have also claimed that the judiciary was encroaching on the powers of the legislature.

India's richest 1% own more than 40% of total wealth: Oxfam

The richest one per cent in India now own more than 40 per cent of the country's total wealth, while the bottom half of the population together share just 3 per cent of wealth, a new study showed on Monday. Releasing the India supplement of its annual inequality report on the first day of the World Economic Forum Annual Meeting here, rights group Oxfam International said that taxing India's ten-richest at 5 per cent can fetch entire money to bring children back to school. "A one-off tax on unrealized gains from 2017-2021 on just one billionaire, Gautam Adani, could have raised Rs 1.79 lakh crore, enough to employ more than five million Indian primary school teachers for a year," it added. The report titled 'Survival of the Richest' further said that if India's cent, or taxing the top 10 billionaires are taxed once at 5 per cent would nearly cover the entire amount required to

bring the children back into school," it added. Oxfam said the report is a mix of qualitative and quantitative information to explore the impact of inequality in India. Secondary sources like Forbes and Credit Suisse have been used to look at the wealth inequality and billionaire wealth in the country, while government sources like NSS, Union budget documents, parliamentary questions, etc have been used to corroborate arguments made through out the report. Since the pandemic began to Nov 2022, billionaires in India have seen their wealth surge by 121 per cent or Rs 3,608 crore per day in real terms, Oxfam said. On the other hand, approximately 64 per cent of the total Rs 14.83 lakh crore in Goods and Services Tax (GST) came from bottom 50 per cent of the population in 2021-22, with only 3 per cent of GST coming from the top 10 per cent. Oxfam said the total number of billionaires in India

increased from 102 in 2020 to 166 in 2022. The combined wealth of India's 100 richest has touched USD 660 billion (Rs 54.12 lakh crore) - an amount that could fund the entire Union Budget for more than 18 months, it added. Oxfam India CEO Amitabh Behar said, "The country's marginalised Dalits, Adivasis, Muslims, Women and informal sector workers are continuing to suffer in a system which ensures the survival of the richest. The poor are paying disproportionately higher taxes, spending more on essentials items and services when compared to the rich.



The time has come to tax the rich and ensure they pay their fair share." Behar urged the Union finance minister to implement progressive tax measures such as wealth tax and inheritance tax, which he said have been historically proven to be effective in tackling inequality. Citing a nationwide survey by Fight Inequality Alliance India (FIA India) in 2021, Oxfam said it found that more than 80 per cent of people in India support tax on the rich and corporations who earned record profits during the Covid-19 pandemic. "More than 90 per cent participants demanded budget measures to combat inequality such as universal social security, right to health and expansion of budget to prevent gender-based violence," it added. "It's time we demolish the convenient myth that tax cuts for the richest result in their wealth somehow 'trickling down' to everyone else. Taxing the super-rich is the strategic

precondition to reducing inequality and resuscitating democracy. We need to do this for innovation. For stronger public services and for happier and healthier societies," said Gabriela Bucher, Executive Director of Oxfam International. Oxfam India urged the Union finance minister to introduce one-off solidarity wealth taxes and windfall taxes to end crisis profiteering. It also demanded a permanent increase in taxes on the richest 1 per cent and especially raise taxes on capital gains, which are subject to lower tax rates than other forms of income. Oxfam also called for inheritance, property, and land taxes, as well as net wealth taxes, while enhancing the budgetary allocation of the health sector to 2.5 per cent of GDP by 2025, as envisaged in the National Health Policy. Oxfam said it also wants public health systems to be strengthened and budgetary allocation.

Budget 2023: What households, investors are expecting from FM Nirmala Sitharaman

New Delhi:

Though it's quite customary to have a wish list from every industry before every year's budget, I feel Budget 2023 would be very important from multiple points of view. It's coming at a time when the world is grappling with concerns on recession and slowdown, issues of inflationary pressure, and geo-political concerns which warrant spending more on securing your defence forces. Also, this being the last full budget before the elections in 2024, the government would be on the front foot on reforms and pushing for growth in the economy across sectors. I believe that the budget would have a two-pronged focus. One would be to increase household income for the middle-class and lower-income groups. The second focus would be to take India into the next stage of growth into becoming a \$5 trillion economy over the next 4-5 years. With regard to increasing household income, we believe this could see again as a two-pronged approach. One would be to increase the Direct Tax exemption slabs for the middle class where existing slabs could be increased higher thereby increasing the



disposable income in their hands. The second would be to provide more tax relief with regard to home loan repayment which would thereby also provide the much-needed push to the Real Estate sector which is one of the key sectors for economic activity and growth. However, the flip side of this is that the top tax bracket could see some more pain coming along their way. Also, we could see the limit under 80C also being increased as it has largely remained untouched for a long time. Coming to the second key focus area for the budget with regard to taking India into achieving the \$5 trillion target, I feel government would front end capital expenditure and infra spends in order to build capital assets and at the same time also address job creation goals for

the government. Also further incentivizing domestic manufacturing through incentives could be seen coming up in the budget. As the world sees a rebalance of power and economic growth centers, the seed planted through PLI schemes and tax incentives needs to be carried ahead further by attracting more capital expenditure from the private sector too. We could see more focus from the government to promote green energy and sustainable energy sources. From an equity investor's perspective, I think a major thing to look out for would be a change to the LTCG tax rate or tenure of holding for equity. Either of the two could be tinkered with to bring more parity with the taxation of other asset classes. This would surely be seen negatively by

the market in the near term in an environment where returns from equities in the last 12 months have been dismal. However, I think the government has made it clear on various forums that in a calibrated manner they plan to do away with the differential treatment given to different asset classes and bring in simplicity and uniformity. In order to promote the startup ecosystem further in the country, we could see some tax benefits for the unlisted equities for the PEs and VCs in the country. All in all, I am of the view that the budget will have a positive tone to it and be more growth-focused and less of a socialistic budget. Through we could see some customary PM schemes being launched but that would be within the regular scope and size of budgetary allocations. India has definitely come a long way from the earlier times when the government used to wait for the budget to make all important announcements. What we see today is announcements and policy changes being made during the entire year as and when decisions are made and that is in my opinion the right thing to do.

WPI inflation cools down to 22-month low of 4.95 per cent in December on softening food prices

New Delhi:

The wholesale price-based inflation declined to a 22-month low of 4.95 per cent in December 2022, mainly due to fall in prices of food articles, especially vegetables, and oilseeds. The Wholesale Price Index (WPI)-based inflation was 5.85 per cent in November 2022 and 14.27 per cent in December 2021. Last month, declining prices of vegetables and onions pulled down inflation rate of food articles by (-)1.25 per cent. However, wheat, pulses and potato remained expensive, along with protein rich items like milk and 'egg, meat and fish'.

Wholesale inflation in vegetables declined 35.95 per cent, and onion by 25.97 per cent. In non-food articles, oilseeds and minerals too recorded a decline in inflation by 4.81 per cent and 2.93 per cent, respectively. "The decline in the rate of inflation in December 2022 is primarily contributed by fall in prices of food articles, mineral oils, crude petroleum & natural gas, food products, textiles and chemicals," the commerce and industry ministry said in a statement. The last low level of WPI inflation was recorded in February 2021 at 4.83



per cent. The deceleration in WPI comes in line with retail inflation data released last week which showed CPI inflation eased to 5.72 per cent in December. The consumer price index (CPI)-based inflation remained within the RBI's upper tolerance limit of 6 per cent for the second month in a row. As per data released on Monday, WPI inflation in fuel and power rose marginally from 17.35 per cent in November to 18.09 per cent in

December 2022, while in manufactured products it softened to 3.37 per cent last month. WPI inflation in crude petroleum & natural gas cooled to 39.71 per cent in December, against 48.23 per cent in the previous month. Barclays MD & Head of EM Asia (ex-China) Economics Rahul Bajoria said similar to CPI, WPI is also losing momentum, driven by both base effects and falling food prices. "We expect further declines in import costs to keep WPI contained in the coming months, but CPI pass through may be limited for now," Bajoria said.

Energy, Chips, Taiwan: Flashpoints for 2023 in a Fractured World

New Delhi:

A new age of great-power rivalry is redrawing the map of the world economy and forcing business chiefs to navigate around a growing number of global flashpoints. With a hot war raging in Europe and a cold one escalating between the US and China, the rest of the world is under pressure to pick sides. Political leaders are imposing new economic priorities, as they battle to avert shortfalls of vital commodities — from natural gas to semiconductors — and use the ones they control as leverage. For the titans of commerce gathering in Davos this week, all of this marks a shift away from the era of ever-closer global ties, when big business thought it had succeeded in making the world flat. Now it's in for a bumpy ride. Debate at the World Economic Forum will revolve around these emerging geo-economic risks. Some center on key goods or markets — like the worldwide focus on energy security since Russia's invasion of Ukraine, or the US campaign to deprive China of cutting-edge technology. Others are geographic, above all the threat of conflict in Taiwan. "We're living in a more fragmented world that includes financial fragility, so one

thing that is clearly on everyone's mind is: Where to invest, and how to invest, in a more multipolar world," said Karen Harris, New York-based managing director of the Macro Trends Group at consulting firm Bain & Co., before flying out to Davos. Here is an overview of some of the likely hotspots this year in the increasingly fraught world of economic statecraft.

Weaponized Energy

Energy is at the heart of the economic war that's pitting the US and allies against Russia. Both sides have sought to weaponize it, and there's potential for further turmoil in 2023. President Vladimir Putin says Russia won't sell oil to any nation participating in price caps that the US and its Group-of-Seven allies are trying to impose. For now, that means a \$60 per barrel limit. The G-7 rules have helped push Russian crude exports well below that threshold — potentially squeezing Putin's ability to finance the war. Russia still has buyers, notably India, China and Turkey. It also has the option of shutting down supply altogether, which would wreak havoc in oil markets — threatening a repeat of last year's crude-price spike that pushed inflation higher everywhere. It's not all about crude oil. Similar

curbs on refined Russian products like diesel are due to kick in next month, and some Western officials worry that they could trigger shortages. And the shutdown of Russian natural-gas pipelines has left a big hole in global supply. So far, a warm European winter has helped make the shortfall less acute, and bring gas and power prices down. Still, this year will likely see nations scramble to lock in scarce shipments of liquefied fuel.

The Battle for Chips

Semiconductors, crucial components of everything from electric cars to ballistic missiles and new artificial intelligence technologies, are emerging as one of the global economy's most important battlegrounds. Over the past year, the Biden administration has wielded various tools including export controls to prevent China from buying or manufacturing the most advanced chips. It's also launched a \$52 billion subsidy program for the domestic chip industry, to bring manufacturing capabilities back home. The US says its blunt-force restrictions are aimed at Chinese military capabilities, while Beijing says they're part of a wider effort to halt China's economic advance. Whatever the case,



American allies will need to be on board for the curbs to work. The Netherlands and Japan, which host some of the most advanced chip firms, have already agreed. Compliance will come with a cost, as the firms that make chips or machinery to build them may lose out on the vast Chinese market. Meanwhile Beijing is ploughing cash into its own semiconductor industry — though cutting-edge technologies will likely be tough to replicate — and could seek to retaliate if restrictions are tightened.

War Over Taiwan?

US and European leaders fear the next front in the new cold war — which could turn hot — will be Taiwan. China has claimed Taiwan as its own since the ousted nationalist government in Beijing fled there after the communist revolution. The Pentagon said recently it sees no sign of an

imminent attack. But it expects more of the aggressive behavior that's become a pattern since former House Speaker Nancy Pelosi triggered a furious reaction from Beijing by visiting the island in August, with an increase in military drills and intrusive actions by air and sea. President Joe Biden has promised to send American forces in the event of an invasion, something he's ruled out doing in Ukraine. On top of the obvious risks of a direct conflict between superpowers, there's an economic dimension to the standoff. As home to the world's largest chip maker, TSMC, Taiwan is critical to all kinds of global supply chains. Even an escalation short of war, like a Chinese blockade, could set off a colossal domino effect. A Chinese move against Taiwan, and the likely Western response, "is a contingency that everyone

is planning for," says Tim Adams, chief executive of the Institute of International Finance. "Every single firm is gaming out what those sanctions would look like, and who would be an ally to the US."

'Friendshoring' and Subsidies

Governments are increasingly willing to use their economies as tools of statecraft. On offense, that might mean denying rivals access to goods or markets. On defense, it means only allies can be trusted to deliver strategic supplies, an idea known as friendshoring. But friends can fall out, and the friendliest shore of all is at home. That's why nations are ramping up subsidies for their domestic producers — a shift away from free-trade orthodoxy that's already causing frictions. The Biden administration is spending more than \$50 billion to boost chipmakers

at home, and also backing the electric-vehicle industry as part of a \$437 billion plan to fight climate change. Europe reacted furiously, accusing its ally of unfair trade practices that incentivize companies to relocate to the US, and says it may roll out financial support of its own. The risk is a global subsidies race where the winners are the countries with the deepest pockets, and the losers are the economies in the developing world already suffering from growing debt burdens.

The Dollar's Reign

More and more countries — not all of them American adversaries — are seeking ways to conduct more business outside of the dollar, because they see the US turning its currency into a tool for advancing foreign-policy objectives. The Biden administration froze some \$7 billion of Afghanistan's central bank reserves, to keep money out of the hands of the country's new Taliban rulers. The US and European Union are seeking ways to legally confiscate some half-trillion dollars worth of Russian reserves and use them to rebuild Ukraine. It will likely take many years to displace the dollar as the world's reserve asset, if that happens at all. The

greenback's safe-haven status was evident last year when it soared in the turbulent early months of the Ukraine war. It's entrenched in everything from central banking to commodity trade, and there's no clear alternative. Still, among countries like China, Russia and Iran — as well as India and the Gulf energy giants, which have more amicable relations with Washington — the search is on for ways to build trade links that eschew the dollar. Chinese President Xi Jinping's visit to Saudi Arabia last month, which saw talk of energy deals priced in China's currency with investment set to flow the other way, may be a sign of things to come. The risk for the US and its allies is twofold. Their sanction weapon, which relies on dollar dominance to be effective, may lose some of its force. And they may face higher inflation, as trade deals between non-Western economies lock key commodities out of the market, pushing prices up for other buyers. "The US dollar is a hex on all of us," George Yeo, former foreign minister of Singapore, said at a conference last week. "If you weaponize the international financial system, alternatives will grow to replace it." (Agencies).

Two groups face off while molesting kite flying girl, 4 cars-8 bikes vandalized, stone pelting caught on CCTV

Surat,Umang Rawal:

In KhalifaMohalla of Nanpura in Surat, there was a general brawl between two groups over kite-flying harassment, with the mobs clashing and pelting stones at each other. 4 people also sustained minor injuries in the stone pelting, while 4 cars and 8 bikes were vandalized by the mob. Eighth police rushed to the spot and took more than 10 complaints face-to-face. In the morning there is a splash and in the afternoon it is dirty. In KhalifaMohalla of Nanpura, some people were molesting a girl by flying a kite in another's building. Deliberately throwing down the kite was annoying. There was a general brawl on this matter as well. Not only that, on Sunday morning too, the noise was normal. On Sunday afternoon, both the groups came face to face and mobs were pelting stones at each other. The entire incident has been captured in the



CCTV camera. Due to this incident, people living in Nanpura area felt fear. The police have registered a case on the complaint of rioting and launched a search to nab the accused. Vehicles were damaged. Four people were injured in stone pelting over kite flying. Besides, cars and bikes were also damaged here. However, as soon as the incident was reported, a convoy of 4 police stations reached the spot and brought the matter under control. After that, a tight police presence was

arranged on the spot. The incident took place within the limits of Athwalines Police Station. So a complaint has been registered against both the groups. The entire incident of stone pelting was captured on CCTV. The incident of kite flying was caught on CCTV. It can be clearly seen that first a crowd of 25 to 30 people comes and then the people standing on the terrace are called down. But they are stoned by the crowd who do not come down. The stone pelting

goes on for a minute and then the crowd disperses by pelting stones. The injured made serious allegations. The injured Mohammed Sheikh said that he had gone for a walk. Three to four youths were also on the terrace. They were molesting the girl. When we asked to call the police, they used to be called, call them. Then they ran away when the police car came. However, the police car kept coming and going. Because, the person in front said that everything has fallen. A complaint was made against us: injured, The injured person said that a complaint has been lodged against us in the police station, so the police have taken my father, brother and my nephew. But we have not raised our hand against anyone. Those people have attacked us. Our vehicles have also been damaged by the blow. We have also installed CCTV there.

Group Clash over Kite Patch War: Vasi Uttarayan in Mehsana, five men surrounded an old man and thrashed him with iron pipes

Ahmedabad,Umang Rawal:

In Mehsana, an old man was killed in public on the day of VasiUttarayan. A simple brawl between two factions of the society over fighting kite patches had turned into a fierce fight. In it, five headstrong persons surrounded the old man and hit him with sticks and iron pipes, and he died during treatment. The two groups came face-to-face as the usual brawl escalated, NagjibhaiVanjara was surrounded by five men and hit on his head with sticks and iron pipes and was taken to the Civil Hospital for treatment in a bloody condition. In Civil, the doctors talked about moving to Ahmedabad for further treatment. However, he died before moving to Ahmedabad. A complaint was



registered against Panch, It has come to light that some people on the other side have also suffered injuries in the incident of fighting. At that time, the killers Vanarav Babuji Thakor, HareshKeshav Lal Rawal, Chirag Haresh bhai Rawal, Bobby HareshbhaiRawal and Sunil RameshchandraVyas were charged under section 143, 147, 148, 149, 302, 323, 504, 506(2), 114 as well as G.P. As per acct no 135 in mehsana a division magial nagjibhai vanjara has filed a complaint. mohanpura village fatal attack in malasa case. Even on the day of Uttarayan in Mehsana, an incident of attack came to light over a trivial matter. In Nanidau Mohanpura village, a young man was attacked by four persons after he refused to give him spices. After that the



women came running as the matter became more intense. Four persons attacked two youths and a woman with a knife, and one youth suffered serious injuries in the abdomen. The seriously injured youth was rushed to the hospital for immediate treatment.

No Evidence of Myanmar Artillery Hitting Mizoram: State Government

New Delhi:

Contrary to claims, there was no proof that artillery from Myanmar had hit Indian soil, the state government said on January 15. Residents of Farkawn in Mizoram's Champhai district, which lies on the Indo-Myanmar border, had said that a bomb from a military operation by Myanmar that was targeted at Myanmar resistance fighters had dropped in their village on January 10. The Assam Rifles had denied that any explosion took place on the Indian side on January 12.

Air strike strayed to India?

On January 10, a Myanmar newspaper The Irrawaddy had reported that a Myanmar army airstrike on Mount Victoria, the headquarters of the Chin National Front (CNF) in Chin State on the western border of the country, had claimed the lives of five ethnic Chin resistance fighters,



including two women. One of the five bombs launched by the army during this strike landed on the Indian side, in Mizoram's Champai district, it said. The press quoted McLalramenga, president of the local Young Mizo Association chapter, as saying that a bomb landed "around 30 metres" from the river Tiau. The river marks the international boundary between India and Myanmar. The report also quoted a Champai district official saying that at least one shell fell on the Indian side and though a truck parked on the bank of the River Tiau close to the border was damaged,

there was no casualty. The bombing continued on January 11 too, causing residents of Farkawn to stay indoors in fear, as per the news report. A Press report also quoted Lalramliana, the president of Farkawn village council in Champai, as saying that a bomb was dropped near Tiau river on the Mizoram side and that a truck owned by a village council member had been damaged. The Assam Rifles had denied that an aerial strike had hit Indian territory on January 12.

'No proof, only shrapnel'
The Mizoram government said on

January 14 that there was no evidence that an airstrike hit Indian soil, reported The New Indian Express. It quoted James Lalrinchhana, the district magistrate of Champhai, as saying that while pieces of shrapnel were recovered from the Tiau riverbed, there was nothing to support people's claims that Mizoram was hit. As per the news report, Lalrinchhana submitted a report based on these findings to the Home Department on Friday evening. The district magistrate was hopeful that the situation would return to normal soon, the report said.

TMM 2023 RACE DAY SEES: Ethiopia's Lemi and Haymanot set course records while Gopi T tops Indian elite field

MUMBAI,Babita Murdeshwar:

Ethiopian runners took top honors at the 2023 Tata Mumbai Marathon (TMM) held on Sunday, January 15. The men's elite category was won by HayleLemi of Ethiopia, who finished in a new course record of two hours, seven minutes and 32 seconds. His compatriot Anchialem Haymanot finished first among elite women, covering the distance in 2:24:15, another new course record. Lemi was followed to the finish line by Philemon Rono (2:08:44) and HailuZewdu (2:10:23). In the women's category, RahmaTusa (2:24:22) finished second and LetebrhanHaylay (2:24:52) finished third. The women started their race at a fast pace and there was a keen tussle between five Ethiopian runners at the midway stage. WorkneshAlemu, the 2019



champion here, drew from her past experience on the course to take the lead at that point. However, Haymanot, a marathon debutant, broke away from Alemu. RahmaTusa, two-time Rome Marathon winner, and 2022 Sydney marathon runner-up LetebrhanHaylay ran shoulder-to-shoulder with her. "Running along with these two experienced runners with fast timings to their credit was really a challenge, but I gained much experience from them," Haymanot said at a post-race press conference. Among elite Indian men, Gopi T (2:16:41) finished first followed by Man

Singh (2:16:58) and KalidasHirave (2:19:54). The Elite Indian podium finishers were richer by Rs 500,000, Rs 400,000 and Rs 300,000, respectively. Meanwhile, Parul Chaudhary bettered her course mark in the women's half marathon and Murligavit won the men's crown. The podium finishers took home Rs 100,000, Rs 75,000 and Rs 60,000, respectively. In the elite Indian women's category, Chavi Yadav (2:50:35) placed first; AratiPatil (3:00:44) placed second and Renu Singh (3:01:11) Third. Gopi fell short of the upcoming Asian Games cut-

off of 2:15 but said the win in India's largest marathon gave him a tremendous boost. "It felt good to be back after three years. I maintained a good pace for the first 30-odd kilometres but slowed down towards the end," the Army runner told a news conference. "I never give up," added Gopi, who previously won in 2018. Bhopal's Chavi said she was running the classic distance for the first time. "I didn't run more than 25 km even in training," she told a news conference. AratiPatil finished second, over 10 minutes behind, and Renu Singh was third. Lemi, the overall

winner of 2023 TMM, had won the 2016 edition of the Boston Marathon. The 2016 Bostan Marathon winner ran alongside the defending champion and countryman DeraraHurisa, Kenyan Philemon Rono and half a dozen other runners as they passed through the iconic Rajiv Gandhi Sea Link towards the halfway mark. Lemi, Rono and another Ethiopian HailuZewdu broke away from the rest of the group at the 26th km. The three athletes climbed the Peddar Road together on their return journey. Lemi increased his pace while coming down to enter Chowpatty beach corner

and started running on the Marine Drive well ahead of the other two. Tata Mumbai Marathon was being held after a gap of two years owing to the COVID-19 pandemic. According to news reports ahead of the event, over 50,000 people were due to participate across categories ranging from elite and amateur marathons to the half marathon, the 10K and the dream run. In the open category, the overall winners in the men's marathon were Nanjundappa M (2:27:41), NihalBaig (2:28:17) and Manoj Kumar Yadav (2:29:02). Overall winners in the women's category were

Sarswati Rai (3:14:26), Manisha Joshi (3:18:39) and Darishishalanguh (3:22:29). In the half marathon, the top three finishers among men were Murligavit (1:05:16), Ankit Deshwal (1:05:45) and Dipak Kumbhar (1:05:48). Among women, the winners were Parul Chaudhary (1:15:03), Nandini Gupta (1:24:09) and Poonam Sonune (1:24:56). The 2023 edition of TMM will be remembered for its supportive weather conditions. For the major portion of the race, the weather was quite cool. Thanks to infrastructure projects commenced years ago yet to be completed in the city, the route of the half marathon was altered. This time the half marathon began in Mahim, proceeded towards Bandra and the Sea Link and then mostly followed the route of the previous years.

Editor's Say

What Lies Behind Mohan Bhagwat's Justification of Hate Speech and Violence?

“Hindu society is at war.” This is how Mohan Bhagwat, the chief of the Rashtriya Swayamsevak Sangh (RSS), defends the hate speech and bigotry by the votaries and foot soldiers of Hindutva against Muslims and Christians. The fact that hate speech and violence have now become torrential and are getting more brazen with each passing day is explained by the fact that the war is not small. It is a 1000-year-long war, which has not ended. It is a continuous war, like the permanent revolution of Mao. If we are to believe Bhagwat, Hindus are in a protracted war against several enemies: foreigners, foreign influences and worst of all, internal enemies. Can you expect politeness and civility from those who have to fight a multi-pronged war with just ten hands, he asks. Bhagwat is neither the first nor the only one to suggest that there is valid a reason for the hate speech directed against Muslims and Christians. Many have called for Hindus to take up arms, to keep them ready to chop off the heads of ‘enemies’. In fact, Bhagwat’s claim was preceded even by the Delhi police, which told a court in Delhi that the call to Hindus to arm themselves in a mass meeting in Delhi was actually an exercise to protect ‘community ethics’. Bhagwat is a magnanimous man. Ideally, he would not prefer this aggression in Hindus. But he can appreciate their situation. They are at war. Two days after Bhagwat legitimised hate speech, the Supreme Court asked the Delhi police about the reason for its inaction against Suresh Chavhanke, who is accused of hate speech. Bhagwat has supplied an argument to the state’s counsel. The police can now quote the respected Mohan Bhagwat to tell the court that aggressive language is inevitable as the Hindus are in the midst of a 1000-year-long war. Remember, Bhagwat is defending those who have been calling for the mass slaughter of Muslims, rape of Muslim women, the boycott of Muslim businesses, those who put Muslim women on auction online or those who exhort Hindus not to sell houses or land to Muslims or those who campaign attack Christians for alleged illegal conversions. He explains away all the fear-mongering against Muslims by saying that in a war, it is natural for people to get suspicious. Hindus have to be alert as enemies come with many faces. There are good people in Muslims, he admits, but how do you differentiate good from bad in a war situation? So it is only natural for all Muslims to become suspects in the eyes of the Hindus. Bhagwat’s not-so-oblique legitimisation of hate speech reminded me of the statement made by K.K. Shastri, a Vishwa Hindu Parishad (VHP) patriarch, after the massacre of Muslims in Gujarat in 2002. He admitted that said that the VHP had prepared the list of Muslim properties to be attacked. He added, “The youngsters have done even those things which we don’t like. We don’t support it. But we can’t condemn it because they are our boys. If my daughter does something, will I condemn it?” Shastri told Sheela Bhatt that all this “had to be done” (karvun j pade, karvun j pade). It was war, after all. And excesses happen in wars, one must understand.

RSS finally owning up to its acts?

This is what Bhagwat wants us to appreciate. Now, the RSS is in a position of strength and can own the violence done in the name of Hindus – unlike in the past. Never before has it owned up to violent acts done by its men or the Sanghparivar. Godse was excommunicated, the demolition of the Babri Mosque was attributed to the over-enthusiasm of karsevaks and hundreds of incidents of anti-Muslim violence were disowned. But that was a different time. It needed to have plausible deniability to protect itself from the law, even though many law keepers were largely sympathetic to it. But now, the law is in the hands of the pracharaks of the RSS. The state apparatus has also merged itself with the ideological regime of Hindutva. So, it can now safely own the violence. It is also a fact that many other groups that espouse Hindutva have sprung up that are not part of the RSS parivar. They have many followers, commit violence and spread hate. But the RSS cannot let the mantle of Hindutva go to any other body than itself. So, it has to show that it is in control of everything being done in the name of Hindutva. That is another reason behind the RSS chief openly defending hate speech and violence. This is the only significant part of the long interview Bhagwat gave to the mouthpiece of the RSS. Other things he spoke about – like “accommodating the LGBTQ community” – are only meant to help those people who want to look for things to defend the RSS. But RSS insiders know that these things are for show and not to be taken seriously. Let us remember that the RSS once spoke out against caste divisions. But the message that the RSS cadre took from it was to other Muslims and Christians and treat them as aliens and enemies. It goes without saying that the fountainhead of the ideology of anti-Muslim and anti-Christian hate and violence has no right to advise these communities about how to live. Since its inception, the RSS has been telling Muslims that they would be given safety only on one condition: follow certain restrictions. But who will tell the RSS chief that he has no authority to issue a diktat to Muslims? Bhagwat’s excuse for the hate and violence meted out against Muslims is that they are “supremacists”. Was this the reason why Akhlaq, Tabrez, Junaid or Pehlu Khan were killed? Is this why Hindutva gangs attack Muslims regularly, to beat the supremacism out of them? Then, there are some analysts who tell us that the stature of the RSS chief has been lowered because of the rise of a swayamsevak named Narendra Modi. Therefore, Bhagawat is trying hard to prove his relevance by issuing such statements, to demonstrate that he is still in command. These are excuses to say that the justification of hate speech should not be held against him. He has well intentions for Muslims but has to maintain his credibility among the masses. But these arguments are no consolation for Muslims and Christians, who not only have to face the brunt of hate speech and violence but also have to watch people legitimise and justify these actions.

The Government Wants a ‘Committed Judiciary’ – And Could Be Close To Getting One

Ask yourself one question: Do I want an independent judiciary or a committed judiciary? To answer the question, you may (perhaps) need to know the consequences of having a committed judiciary versus an independent judiciary. Although the consequences are quite obvious, a short question to assist you in making a decision is this: Would you like to play in a match in which the umpire or referee is committed to one of the teams or one of the players? I am not saying we have a committed judiciary, but we are being driven in that direction. The recent utterances of law minister Kiren Rijju, obviously on behalf of the government (otherwise he would have been sacked long back), make it quite clear that the government wants a committed judiciary, as Mrs Indira Gandhi did at one point of time. Strange, isn’t it that the government is following in her footsteps, without acknowledging it? Recent developments suggest that the government is inching towards having its way. My appeal: We have to stop the juggernaut and stop it now.

Past experience

Mrs Gandhi’s government advocated a committed judiciary and even superseded three judges of the Supreme Court (Justices Manilal Shelat, A.N. Grover and K.S. Hegde) and appointed the fourth (Justice A.N. Ray) as the Chief Justice of India (CJI). A couple of years later, the government superseded Justice H.R. Khanna and appointed Justice M.H. Beg for the same position. The attempts were brazen and were met with strong resistance from the Bar, but the government had its way. Fortunately, the idea of a committed judiciary was eventually dropped for a variety of reasons, which need not be discussed. While following in Mrs Indira Gandhi’s footsteps, the government is avoiding the missteps she made. The attempt is not overt, as of now, but not so subtle as well. Slowly but surely, the government is moving ahead and the results of the machinations will be apparent, not now, but in a few years. Why do I make this pessimistic prognosis? The answer lies in the government’s approach to the procedure for the appointment of judges. Silences in the procedure and process, which is built on trust and mutual respect, are taken advantage of by the government, notwithstanding the Supreme Court collegium (SCC) which, I am afraid, will become irrelevant in a couple of years (if not sooner) should the present trend continue. The government says that it must have a say in the appointment of judges, but with the Supreme Court striking down the National Judicial Appointments Commission, it has no say in appointments. Really? Let me briefly outline the procedure for the appointment of judges to the high court and the Supreme Court, as per the Memorandum of Procedure (MoP). The application of the procedure by the government will demonstrate whether it has a role and how it is being played for having a committed judiciary in the long run.

Memorandum of Procedure

The chief justice of the high court, in consultation with the next two senior judges (called the high court collegium or HCC) recommends lawyers and judicial officers for appointment as high court judges. The HCC may consult other judges and lawyers – there is no prohibition, since the idea is to get the best persons. Ask a former chief justice of a high court and you are likely to be told that he or she has also



taken the opinion of somebody or the other outside the HCC at some point of time. I have done that as a chief justice of the high court, following what my chief justices in the Delhi high court have done, including taking the views of well-known and respected lawyers. The MoP also entitles the chief minister of the state to suggest a candidate for consideration by the chief justice. This may have happened on some occasions; I can’t say for sure. It depends entirely upon the chief minister, but more importantly, it is clear that the state government has a say in the recommendation process. The problem here is that if the chief minister makes a recommendation and the chief justice does not agree, the CM may not process the case of those recommended by the chief justice. This has happened in the past on (at least) one occasion and will certainly happen in the future also. The only answer to this is transparency in the process and putting out a chronology of dates and events. The recommendation by the chief justice (and the HCC) is sent to the governor of the state, the chief minister and the law minister, as per the MoP. The recommendation is also sent to the CJI. Each of these authorities is expected to act upon the recommendation. The governor and the chief minister make their inquiries and their views are sent to the law minister, who is also expected to make independent inquiries, on behalf of the Union government, through the Intelligence Bureau and any other channel that he may wish. Based on the inputs received from the state government and inputs received independently by the Union government, an opinion is formed by the law minister, on behalf of the Union government, and conveyed to the CJI. The law minister is not a post office, as rightly stated by one law minister, but if he chooses to act as a postman and not record the facts and his views and convey them to the CJI, that’s his problem. So, when the recommendation reaches the CJI from the law minister, it is expected that every authority has done their homework and put on record whatever they may have to say, including any objections or reservations that anybody may have. The CJI along with the next two senior judges then considers the recommendation based on the inputs received and while doing so, also takes and considers the views of the judges of the Supreme Court associated with the high court, either as a judge as some point of time or as a chief justice of that high court. This is provided for in the MoP. There have been occasions when as many as four or five non-collegium judges have been consulted. In other words, the consultation process within the Supreme Court is quite rigorous. At one point in time, the candidates

were invited to meet the judges in the SCC (not for an interview) but to have a chat and obtain any clarification, if required and also meet the person being recommended. It is thereafter that the SCC conveys its views to the government either accepting or partly accepting the recommendation of the high court or not accepting it or deferring it for obtaining further inputs. After the SCC conveys its acceptance of the high court recommendation, the government is expected to process the file by obtaining necessary documentation from the high court, such as the medical certificate of the candidate and the name of the candidate in Hindi and English. After this formality is over, the recommendation is sent by the prime minister to the president for issuing a warrant of appointment. Now, here is the crunch part. What has started happening with increasing frequency is that the government returns the case papers to the SCC for reconsideration. Why should that happen? Is it because of a difference of opinion between the government and the SCC? Everything is on the record, including the opinion of the state government and Union government and all the information provided is considered by the SCC.

The game starts here

Since all information available with the government is placed before the SCC, including the views of the governor of the state and the chief minister and the Union government, on what basis does the government disagree with the SCC? One can understand if some new material comes before the government that needs to be placed before the SCC, but that is usually not the case. It is just that the government has a different opinion from that of the SCC and so the law minister sends the papers back to the SCC for reconsideration. Under these circumstances, the SCC has a fresh look at the recommendation and may decide to reiterate its decision. In such a situation, what does the government do, again with increasing frequency? The government then either asks the SCC for a second reconsideration and in some cases for a third reconsideration or simply does nothing like Little Jack Horner. The law minister simply does not process the recommendation made by the SCC. This is short of telling the SCC that the government does not care for the views of the SCC. The stalemate created by the government frustrated Aditya Sondhi, whose recommendation was not processed for one full year while the case of several others recommended later was processed. He then withdrew his consent. This served the purpose of the government. Unfortunately, the SCC did nothing in the matter, emboldening you know who.

pending consideration with the government. This is the way potential high court judges can and are being treated by the government. Can anybody please explain what’s going on in the post office? With this exercise of naked power, I have no doubt that the government is attempting to suborn the independence of the judiciary, a basic feature of the constitution of India and one of the pillars of democracy.

Appointments to the Supreme Court

Let’s shift focus to the appointment of judges to the Supreme Court. After a recommendation is suomotu made by the SCC of five judges, the MoP obliges the government to accept the recommendation and make the appointment. But consider two events that occurred in the case of Gopal Subramaniam. First, the government stalled his appointment and did not have the courage to inform the CJI of the reasons for doing the unthinkable. This resulted in Subramaniam withdrawing his consent to be appointed as a judge of the Supreme Court (and perhaps the CJI). Second, the government split the recommendation made by the Supreme Court and processed the case of others. This is completely disregarding the fact that always one recommendation is made by the SCC consisting of two or more persons. A former CJI expressed that a recommendation cannot be split up. The government cannot split a recommendation into half or one-third and process the recommendation of one (or more) person to the detriment of others who are left hanging out to dry. The government ought to have returned the recommendation to the Supreme Court (the MoP does not provide for that) with its objections and the SCC would have taken a call on the objections. Although it is in the past, a precedent has been set. Splitting up a recommendation allows the government to pick and choose. It is possible in a given case to split the recommendation and hold back the case of one individual and process that of the others so that the “favoured” one may become the CJI in due course or lose his or her seniority. That is the danger. As mentioned above, though the circumstances were different, Mrs Gandhi’s government twice superseded sitting judges of the Supreme Court. What prevents the government from superseding other judges again in the footsteps of Mrs Gandhi? In fact, Chief Justice K.M. Joseph of the Uttarakhand high court lost his seniority while being considered for appointment to the Supreme Court. He was recommended by the SCC in January 2018, along with Justice Indu Malhotra, then a practising senior advocate in the Supreme Court. The government split the recommendation in half and notified the appointment of Justice Malhotra towards the end of April 2018, after more than 100 days. A day or two later it raised frivolous objections to the recommendation of Justice Joseph. The SCC reiterated his recommendation in July 2018 (it should have done so earlier). Separately, the SCC also recommended two other chief justices for appointment to the Supreme Court. Eventually, all three appointments were notified in August 2018. Significantly, Justice Joseph was ranked junior to the other two judges in the Supreme Court, thereby losing his seniority to both and also to Justice Indu Malhotra.

Hockey World Cup 2023: India produce another brilliant defensive effort but goal-scoring is a worry

As the Indian men's hockey team moves base from Rourkela to Bhubaneswar, the Sundargarh district residents would be a tad disappointed. In the two games that India played in the brand-new Birsamunda Stadium in Rourkela, the hockey was of high quality and the home support was supreme. In their first Pool D game, India blanked Spain 2-0 in front of the 20,000-plus crowd on the back of some fast and thrilling hockey. On Sunday, India played out a nail-biting goalless draw against England in the stadium packed to the rafters once again. There were no goals

to show but it was 60 minutes of lung-bursting and edge-of-the-seat hockey that made for a fantastic spectacle. Yet, despite all the attacking, it was the defending from both sides that tactically stood out from the game. Especially from India's perspective, two back-to-back clean sheets are highly reassuring. After all, India have had the worst defending record among top teams in the FIH Pro League in the last two seasons.

Dogged defending Two of the best sides in the Pool, the result of Sunday's game was to have a big say on the final shape the group takes, and

England wanted to take an early lead. Quick off the blocks, the visiting team earned five penalty corners (PC) on a stretch in the first quarter but all that resulted in no goal. The star of the Indian defence in the brief period was Manpreet Singh who was brilliant as the rusher, reading the angles well and blocking most of the shots. Amit Rohitdas and Harmanpreet Singh were equally good on the subsequent PCs. In the last minute of the game, defender Surender Kumar saved a PC on the line to deny England once again. In total, England had eight PCs in the game but the Indian defence proved to be unbreachable. "We have



been leaking goals since the Tokyo Olympics but now we have got back-to-back clean sheets, that is the positive from this match," India coach Graham Reid said after the match. "We conceded too many penalty corners but at the same time we defended them very well. The defending wasn't just good on the PCs, even in the open play

the Indian players showed some great game awareness to thwart any danger that England posed. Nilam Sanjeep Xess producing a stunning last-minute clearance with a dive as Liam Ansell looked set for a goal in the 24th minute was one of the examples of how good the home team was on the night in front of their own

goal.

Who will score for India?

They were equally good going forward. India made 31 circle penetrations as compared to England's 23. Despite having 47% of ball possession, Harmanpreet Singh-led side produced nine shots on goals. However, the concern is that they didn't convert any of the chances. To add to the headache, Hardik Singh, who has been India's biggest attacking threat so far, had to be taken off the field in the final quarter due to what looked like a hamstringing issue. "It looked pretty bad when he came off but I have gotten an update and

it is not as bad as we originally thought. We will have an update on that, we will see," Reid said about Hardik after the game. Mandeep Singh had a good game and while his skills with the stick posed a lot of danger he wasn't able to convert a glorious opportunity in the 41st minute as he missed the target. Other forwards, Akashdeep Singh and Lalit Upadhyay had an ordinary game. India also failed to convert any of their four PCs and a goal from ace drag-flicker Harmanpreet's stick is still missing. If Hardik, who scored in the Spain game, doesn't return against Wales, India can only find

themselves in more trouble. They now sit second in Pool D behind England despite having four points each. England lead because of a superior goal difference as they had beaten Wales 5-0 in their first game. A direct qualification to the quarter-finals is guaranteed for Pool winners and for that India will need to beat Wales with a big goal margin, however, to do so the forwards will have to rediscover their goalscoring touch on Wednesday in Bhubaneswar. But India may still rue not scoring against England if Paul Revington-coached side makes easy work of Spain in their last Pool game.

India Open: PV Sindhu, Lakshya Sen among title contenders at tournament

New Delhi:

The country's top shuttlers, including reigning champion Lakshya Sen and double Olympic medallist PV Sindhu, will look to keep their date with destiny as they will be title contenders in at least three of the five events when the India Open Super 750 begins in New Delhi on Tuesday. Indian badminton never had this good with as many as three players — Sindhu (7), Sen (10), HS Prannoy (8) in singles world's top 10 and the men's doubles pair of Satwiksairaj Rankireddy and Chirag Shetty at world No. 5 — all coming into the season with loads of success last year. While

seventh seed Sen and Satwik-Chirag, seeded fifth, are entering the USD 900,000 event as defending champions, Sindhu and world No. 13 Kidambi Srikanth are also former champions. However, the past results will count for little as all the big stars of world badminton will be pitted against each other — some of them in the opening round itself — during the upgraded version of India's flagship event. Sen and Prannoy, two most prominent figures of Indian men's singles in 2022, will engage in yet another slugfest in the opening round with the younger of the two hoping to return the favour this time after

last week's opening round reversal in Kuala Lumpur. Sindhu's return after a long injury lay-off at the Malaysia Open was spoiled by long-time nemesis Spain's Carolina Marin, who herself is on a comeback trail having sustained two ACL injuries in both her knees in the last few years. This week, it will be Thailand's Supanida Katethong who will stand in her way in the first round and Sindhu will hope to find her sharpness in attack and strength in defence to avoid any hiccup, having lost to her in the last edition. The former world champion, who has been out of action due to a heel injury since the Commonwealth Games in



August, is likely to face a potential quarter-final clash against Olympic champion Chen Yufei of China. Satwik and Chirag will be brimming with confidence after a semifinal finish at the Super 1000 event last week as they begin their men's doubles campaign against Denmark's Jeppe Bay and Lasse Molhede,

ranked No. 31 in the world. The Indian duo is likely to face a real test in a potential quarter-final clash against top seeds Takuro Hoki and Yugo Kobayashi of Japan. However, no one has a tougher task at hand than former world No. 1 Srikanth, who will open against reigning Olympic

champion Viktor Axelsen, who has extended his record-breaking winning streak by retaining the Malaysia title on Sunday. London Olympics bronze medallist Saina Nehwal, a former winner of the India Open, will begin her campaign against Denmark's Mia Blichfeldt, desperately hoping for a good run to boost her confidence after another injury-ravaged 2022. Young guns Malvika Bansod and Aakarshi Kashyap will have their task cut out against Thailand's world No. 11 Busanan Ongbamrunphan and world No. 24 Beiwen Zhang of the US in the opening round of what will be their first appearance

at the Super 750 level. Among other Indians, Dhruv Kapila and MR Arjun will be missing in action due to an injury but Krishna Prasad G and Vishnuvardhan Goud P will hope for a good start when they square off against the Netherlands' Ruben Jille and Ties Van Der Lecq. In women's doubles, All England semi-finalists and Commonwealth Games bronze medallists Treasa Jolly and Gayatri Gopichand Pullela will meet France's Margot Lambert and Anne Tran in the opening round, while Ashwini Bhat K and Shikha Gautam will open against eighth seeds Pearly Tan and Thinaah Muralitharan of

Malaysia. India's only entry in mixed doubles, Ishaan Bhatnagar and Tanisha Castro will face the Netherlands' Robin Tabeling and Selena Piek. Among international stars, Axelsen, who has lost just three matches in 2022, and Japan's Akane Yamaguchi, who has won four titles in 2022 including the All England, World Championships and World Tour Finals, will be favourites for the crown following their title run in Malaysia. All eyes will also be on the next-gen shuttlers — Japan's new sensation Kodai Naraoka, Malaysia's Lee Zii Jia, former world champion Loh Kean Yew and Thailand's Kunlavut Vitidsarn. (Agencies).

Andrew Tate: Romanian police widen probe into controversial influencer

Bucharest:

Romanian police are expanding their investigation into former kickboxing champion Andrew Tate, seizing a fleet of luxury cars from his Bucharest compound over the weekend, and raiding seven more properties — including a newly renovated villa beneath the Carpathian Mountains. The sight of Mr Tate's shiny dove-grey Porsche perched delicately on the battered frame of a police tow truck neatly captured his shift in fortunes as, through the high black gates of his compound, a slow procession of trucks carried his prized collection of luxury cars to join him in police custody. At the side of the road, a single fan stood watching. "I consider myself a fan," Emmanuel told me. "Every boy likes his lifestyle." "I don't like what I'm hearing about him, but we'll see if it's true. I'll change my attitude if I see proof." Some here see the confiscation of the cars as a sign that the Romanian authorities are preparing for the next stage in this case, securing assets as collateral against potential compensation claims from victims, in the event that Andrew Tate or his brother Tristan are charged with people trafficking. Raids on seven more properties last week are widely seen as a sign that investigators are expanding their search for evidence in the case. In the town of Comarnic, two hours' drive to the north, the Tate villa, freshly raided by police on Thursday, towers over the houses around it. Small homemade sheds perch against the high walls

that surround the property. Neighbours here say the property was fully renovated last year, and only completed a few months ago. Trandafir Beldica lives in a worn housing block beside the main gate to the villa. "The guy in charge of the construction asked me to work on the electrics, but when they explained what they wanted, I told them it was way beyond what I knew how to do," Trandafir told me. Inside, he said, the house has "all the amenities you can think of." "It's extremely luxurious," he explained. "It's divided into flats [and] they could afford to build a swimming pool — things that people like us couldn't even dare to dream of." How Andrew Tate made his money is a key part of this investigation. Police want to know whether he lured women to Romania with promises of a serious relationship or marriage, before forcing or manipulating them into working for him as models in adult entertainment chat rooms. They are also looking into rape allegations made by one of the witnesses. Investigators have confirmed that six women have been identified as potential victims. But last week, two of the women in the investigation publicly denied any mistreatment by the Tate brothers. Andrew Tate's luxury cars were towed away from his compound in Bucharest. The women — who have tattoos reading "Property of Tate" and "Tate Girl" — worked in the compound in Bucharest, where Andrew Tate lived with his brother and the models who staffed



his adult web-cam business. Speaking to Romania's Antena 1 TV channel, one of the women — identified as Beatrice — said she had been "good friends" with the Tate brothers for two years and had "Tate Girl" tattooed on her arm "out of respect for them". The other woman — Jasmin — said she had never seen Mr Tate or his brother Tristan be "aggressive or rude". The BBC has verified their identities with a former member of Tate staff. "I was never threatened," Beatrice said. "If I was, I wouldn't be stupid enough to stay in that house." You can't describe me as a victim in the case file if I'm not a victim. "Describing the moment police first entered the compound in December, Beatrice said 20 police officers charged in and went upstairs to a bedroom where, she says, two other women had locked themselves inside the room in fear of the raid. "They broke the door down. [The women] screamed," Beatrice said. "But the police didn't see that the key to the bedroom was lying on the bed." BBC News has spoken to others who have different memories of the raid. There

is little clarity about what evidence investigators have gathered so far. And among the Tates' former associates, claims, counter-claims and conspiracy theories exist side-by-side. Investigations have also taken in the Tate villa in the town of Comarnic, north of Bucharest. No charges have yet been brought, but Mihaela Dragus, spokeswoman for Romania's National Anti-Trafficking Agency, says the case is already sending a strong message to both traffickers and victims. "The fact that the justice system has decided to keep the brothers in custody, even during the preliminary phase of the [case], sends a very important message," she says. In one of his social media videos, Andrew Tate explains why he moved to Romania in 2017. "One of [my reasons] is the #MeToo era," he says. "People say: 'Oh you are a rapist'. No, I am not a rapist, but I like the idea of being able to do what I want, I like being free." "If she goes to the [Romanian] police and says: 'He raped me yesterday', they'll say ok, do you have evidence? Is there CCTV proof?" None of this is

evidence that Mr Tate was involved in human trafficking or rape, but his assessment of Romania's attitude to sexual crimes is not wrong, says Laura Stefan, a legal expert and prominent anti-corruption campaigner working with the Expert Forum think tank. "In a way, he's right," she told me. "Listening to him, the way he explained why he came here, I could relate to that; I thought he made a good calculation — unfortunately." But she says things are changing. "Romania has a serious problem with trafficking, and I think the Romanian authorities have come to understand that this has to be dealt with," she explained. "That means not only investigating a handful of hotshots, but also working with the victims and providing them with support." Last year, Romania made enough progress for the US Trafficking In Persons report to take it off their watchlist. But the report also repeated concerns about Romanian officials themselves being involved in people trafficking. This case, involving a controversial, high-profile personality with US-British citizenship, has put a fresh spotlight on how Romania handles allegations of organised crime and sexual exploitation. Police have less than two weeks to charge the Tate brothers, or find enough evidence to convince a judge to extend their detention while the investigation continues. Andrew Tate's reputation is on the line. Romania's is too.

Mursal Nabizada: Gunmen kill former Afghan MP at home in Kabul



Kabul:

A former Afghan MP and her bodyguard have been shot dead at her home in the capital Kabul, Afghan police have said. Mursal Nabizada, 32, was one of the few female MPs who stayed in Kabul after the Taliban seized power in August 2021. Her brother and a second security guard were wounded in the attack on Sunday. Former colleagues praised Ms Nabizada as a "fearless champion for Afghanistan" who turned down a chance to leave the country. Since the Taliban returned to power in 2021, women have been removed from nearly all areas of public life. Kabul police spokesman Khalid Zadrani said security forces had started a serious investigation into the incident.

Former lawmaker Mariam Solaimankhil said Ms Nabizada was "a true trailblazer — strong, outspoken woman who stood for what she believed in, even in the face of danger." Despite being offered the chance to leave Afghanistan, she chose to stay and fight for her people," she wrote on Twitter. Stay home, female Kabul government workers told, Finding Afghanistan's exiled women MPs, "If they find me, they will kill me". Ms Nabizada, from the eastern province of Nangarhar, was elected as a member of parliament from Kabul in 2018 and stayed in power until the Taliban takeover. She was a member of the parliamentary defence commission and worked at the Institute for Human Resources

Development and Research. Hannah Neumann, a member of the European Parliament, said: "I am sad and angry and want the world to know!" in response to the killing. "She was killed in darkness, but the Taliban build their system of gender apartheid in full daylight." Abdullah Abdullah, a former top official in Afghanistan's former Western-backed government, said he was saddened by Ms Nabizada's death and hoped the perpetrators would be punished. He described her as a "representative and servant of the people". Many women who had prominent professional jobs in Afghanistan after the US-led invasion two decades ago fled the country after the Taliban returned to power. (Agencies).
